**AN ORDINANCE REVOKING ORDINANCE 2014-01 AN ORDINANCE ADOPTING THE ON-SITE WASTEWATER TREATMENT SYSTEMS PURSUANT TO THE COLORADO DEPARTMENT OF PUBLIC HEALTH AND ENVIORNMENT, WATER QUALITY CONTROL COMMISSION REGULATIONS #43**
