GENERAL INFORMATION

The Assessor is not responsible for high or low taxes. The aim of all Assessors is the equalization of assessed valuations in order that the burden of taxes may be distributed evenly and in accordance with the value of property each taxpayer owns. All real and personal property, not exempt by law, is subject to taxation. It is the duty of the owner of such property to see that it is listed with the County Assessor.

The State Legislature sets the percentage which is used to determine the assessed valuation upon which the levies and taxes are determined. County tax is levied by the Board of County Commissioners. School tax is levied by the School Boards. Town tax is levied by the Town Officials. Special District tax is levied by the district's board of directors.

These levies are certified by the Board of County Commissioners and delivered to the Assessor. These levies are compiled and extended to the properties by the Assessor and the tax roll is delivered to the County Treasurer for collection.

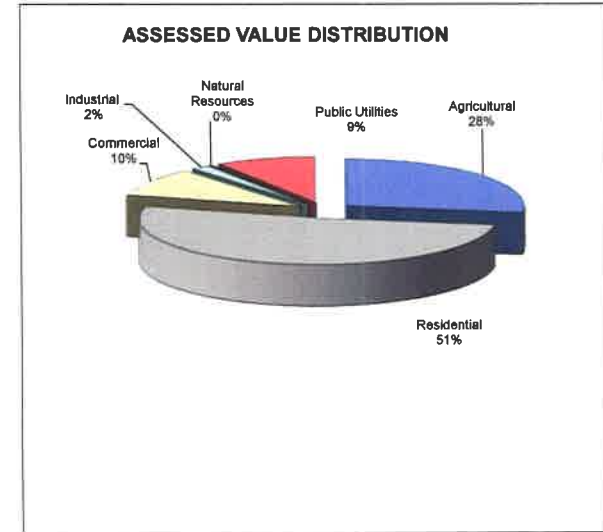

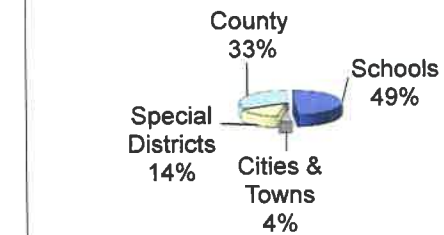
